Motorized Units – the line up area will be on George Street and Cecelia. Enter the line-up area on Madison and north of Cecelia.

Assembly Area for all walking units will be at St.Clair Field on Gulf Drive. Bands will line up in front of Gulf High School.

The Parade will end at the intersection of Main Street and U.S. Hwy 19, New Port Richey. All riders will get off their floats at the intersection of Main Street and U.S. Hwy 19.
